ANNUAL REPORT For the Financial Year 2013-14

1. Introduction

During the year, ICWA continued with its mandated activities and accorded high priority to research and study of political, security, and economic developments in Asia, EU, Africa, and Latin America. Global geo-strategic and geo-political developments were analyzed. The conclusions were disseminated in the form of Sapru House Papers, Issue Briefs and Viewpoints, which were placed on the ICWA website. A large number of events including lectures, conferences and outreach activities were conducted. The Library was improved and new books were acquired. The renovation of the ICWA Auditorium was completed. The ICWA Handbook 2013 with comprehensive information on the structure, objectives, rules, regulations and activities of ICWA was published. New guidelines on external partners and financial support under ICWA Outreach and Publication Programmes were issued.

Shri M. H. Ansari, Vice-President of India, is the President, ex officio, of the Council during the year 2013-14. Ambassador Rajiv Kumar Bhatia joined as the Director General, ICWA & Member-Secretary of the Council on 27th June, 2012. Given the paucity of administrative staff, and the rising work concerning the Phase-II and Phase III of Renovation Project and expansion of the institution's activities, it is strongly recommended that two additional officials, a Director and a Section Officer, may be deployed in ICWA.

(iii) Service Regulations of ICWA

The Draft Service Regulations have been prepared and submitted for vetting by Legislative Department of Ministry of Law and Justice. Other related matters are also receiving their consideration.

(iv) Renovation Work Phase I

The renovation work relating to the Auditorium of Sapru House (Phase I) started in April 2012 and finally was completed in September 2013 at a total cost of Rs.5.72 crores.

(v) Renovation Project: Phase II:

The Renovation work of Lecture Hall was awarded to CPWD after approval of Financial Adviser for Rs. 32,54,458/- . The preparatory work for the next phase of renovation project, involving the Lecture Hall, is over. The renovation work except the installation of the central air conditioning plant has been completed.

(vi) Maintenance Work

All maintenance/cleaning work is undertaken regularly. Painting of the entire building after Phase I of the renovation work was undertaken and completed.

(vi) Security

Security of the building is ensured through one Chowkidar on the pay roll of ICWA and 4 (four) security guards provided by a private company. No serious untoward incident has taken place during the period of review.

7. Status of Court Cases & RTI applications

Court Cases

There are two Court Cases pending as of November 2013:

- i. The case relating to Shri H S Chadha concerning arrears of his emoluments is before the Hon'ble High Court of Delhi.
- ii. One more case was filed in Tis Hazari Court by Shri Tilak Raj, father of late Sh Deepak Raj a former employee of the Council. This relates to the payment of salary and EPF contribution. While the Council is willing to pay all his dues, the dispute in the family of late Shri Deepak Raj as to the legal inherence issue has not yet been settled in the Court.

9. Library

Functioning since 1955, the Sapru House Library has the premier collection in India of documents on international relations and functions as a research library with a stock of 1,41, 324 documents including books (thousands of them are rare), bound volumes of journals, maps, special collections of UN Documents and EU Documents. The Library has automated the entire collection of books, journals, UN & EU documents. The collection is now searchable through Online Public Access Catalogue. The <u>OPAC</u> is accessible from the ICWA web site (<u>www.icwa.in</u>). List of New Arrivals are published on the ICWA web site.

A part of this rich and unique collection in the field of international affairs, comprising rare books, bound volumes of newspapers and press clippings, is available in digital format, useful for researchers and experts in the field of world affairs in India and abroad. The entire collection of ICWA journal - India Quarterly is available in digitized form on the ICWA web-site. The documents of the first Asian Relations Conference held here in March 1947 are also available in digital format. A state of the art Cyber Library is available in the main hall with access to the electronic contents and information. The Library has arrangements with other libraries to allow consultation of the resources for ICWA scholars on the basis of their ICWA ID cards.

To consolidate it as a premier research library, the Library Committee has decided that the library should be equipped with exhaustive research material and documentation in niche areas of Indian foreign policy, with focus on South Asia. Amid the constraints of reduced staff strength, and the need to strike a balance given the relatively limited utilization of the Library facilities and the persistent challenge of upgrading them, a decision was taken by the Library Committee to undertake a selective digitization of a specific category of press clippings and rare books. Within our constraints, suitable action is being ensured, but the Library does need more personnel.

13 Research and Analysis

During the period under review, seven new Research Fellows joined ICWA between April and October 2013. The contracts of Director (Research) and three Research Fellows were renewed following the interviews held on September 21, 2013.

During 2013-14, Research Fellows engaged in publishing Issue Briefs, View Points and articles in media and other academic journals. The ICWA scholars engaged in the study and research on the political, security, and economic trends and developments in Africa, Asia, Europe, United States and the wider global geostrategic and economic environment. In the past one year, ICWA published six Sapru House Papers, thirty books and publications, nineteen Issue Briefs and forty five Viewpoints.

As part of its outreach initiative, ICWA revamped its website to make it more reader friendly and rich in content. It also instituted Book Research Grants, Sapru House Paper Grants and Conference Grants to facilitate and promote research on foreign policy issues.

While ICWA's in-house research capacity is being steadily built, eminent scholars and former practitioners of foreign policy are being commissioned to conduct research on specific areas or projects on India's relations with key regions or countries or major international economic issues. ICWA also hosted a number of international conferences, seminars and workshops as per details given above.

The Core Group on China established around a year ago, completed the task of producing the manuscript which is in the process of publication. The Core Group on Pakistan has held seven meetings and is now preparing a compendium of papers by scholars and experts. Similarly. The Core Group on Afghanistan has also held two meetings and is compiling the papers authored by eminent experts and scholars.
