- 1. Is MEA also aware about FMGL Act 2021 & Indian embassies in various concerned countries are issuing advisory for Indian students, what is the source of Information for such advisories?
- 2. If after following such advisories students takes admission, study for 5-7 years and after coming back to India if NMC (National Medical Commission) deny for registration, then who will be responsible (Indian Embassies or MEA who could not coordinate NMC)?
- 3. I could not get details of Indian Embassy in Dushanbe, Tajikistan on RTI Portal, why it is not listed for RTI or if I missed then let me know how file RTI to Indian Embassy in Dushanbe, Tajikistan?
- 4. Indian embassy in Tajikistan has issued advisory with disclaimer that we are not responsible if anything goes wrong, so do Indian embassy collect such an important information with the concerned ministry or medical council or they collect reviews and feedback from existing students or admission consultants for future of prospective student. Is it good enough to satisfy NMC guidelines for foreign students?
- 5. I saw Indian embassy in Kazakhstan and Georgia & Armenia issuing advisory but changing in few hours or days, did they have finally collected enough and correct information this time or they will again change the details? What if students take admission in between?
- 6. Under RTI Act kindly provide details with documents form the concerned ministries or medical councils of concerned countries about course duration, language of instruction, internship, registration, language exam, license to practice (all details for both local and foreign students) and confirmation on satisfying NMC guidelines by Russia, Ukraine, Belarus, Georgia, Armenia, Moldova, Bosnia, Kazakhstan, Kyrgyzstan, Tajikistan, Uzbekistan, China, Philippines, Vietnam, Bangladesh, Nepal, Egypt, Mauritius, Malaysia, Caribbean Countries and other countries where Indian students are going as it is practically not possible for me to explore every country personally to get all the details, I cannot trust College or Universities, marketing companies or agents as they are biased for their financial interest.

Kindly provide best possible information under RTI Act to save thousands of Innocent Indian student careers and their parents hard earned money.
